- Limits are set in HTL, based on price. In extreme market conditions, company has the right to adjust the limits in order to protect the value of HTL. 90 days after annual dividends are payed, the limit is set at 3 to 15 days. Limits for non active members are 3 to 15 days
- Withdrawal fee for Mini, Starter and Network package is 2%
- For all other packages and ranks withdrawal fee is 1 HTL+1%

In one accounting week, the member's binary reward is calculated up to the maximum limit that belongs to him by rank. If the prize exceeds the limit, the difference is not transferred to the next week

Car bonus:

First of 12 Car bonuses is payed automatically 4 weeks after achieving the rank.

For every (11) next bonus, member must produce requested volume in personal downline (both legs counts – minimum 60% of required volume must be in smaller leg) in 4 weeks period.

In case that he produce less volume, he will receive % of bonus depend on volume he produced.

Example : If member produce 30000 € volume instead of 40000€ volume on Diamond level, he will receive 30000 : 40000 = 0,75 = 75% from 500€ reward = 375€.

The qualification period for requested volume is 4 weeks. Every 5th Saturday a new qualification period begins.

If member qualify for higher level during the 12 months of Car bonus, the member start to receive higher Car bonus from that months and stop receive car bonus for previous rank.

Example: first 6 months member received Diamond rank Car bonus, if he qualify for Blue Diamond in 7th month, he start to receive Blue Diamond Car bonus. From next month further, Diamond Car bonus is not valid anymore.



Available HTL:

Tokens that are permitted to be withdrawn from the platform under the conditions described in the Terms of Service.

Available USDT:

Tokens that are permitted to be directly withdrawn from the platform or converted into HTL and withdrawn from the platform, as described in the Terms of Service.

HTL Shares A:

Tokens that are tied to the Hotelium package or the Freedom Program for a minimum of 12 months in the Loyalty Program plus a minimum of 36 months in the Dividend Program. They can only be withdrawn if first sold to the company at the security price

Promotional HTL Shares A:

Tokens granted to members as part of a promotion, which are revoked after 36 months. During this period, they cannot be sold at the security price.

HTL Shares B:

Tokens that are permanently tied to the platform and cannot be withdrawn. They were obtained either through through various bonuses and rewards or through voluntary conversion of Available HTL into HTL Shares B, through the system conversion of HTL Shares A after the 36-monthdividend program, or through voluntary conversion of HTL Shares A into HTL Shares B.

Bonus packages:

When a member receives a package as a reward, he receives a regular loyalty reward and a regular dividend program for that package. After the dividend program expires, the package is removed from the member's account. Prize packages do not include any form of network commission and do not go into real estate volume.



ECOSYSTEM DESCRIPTION:

After activating the Hotelium Package or the Freedom Program, the **LOYALTY PROGRAM** begins and lasts for 12 months unless it is upgraded. The Loyalty Program duration is 12 months from the last upgrade. During this 12-month period, the member receives a Loyalty reward according to the tier applicable to the selected package, which is paid out every 30 days in **Available USDT**.

After the completion of the **LOYALTY PROGRAM**, the **Dividend Program** begins and lasts for 36 months. During the Dividend Program, members receive dividends every May for the previous year, paid in **Available HTL**.

After the 36-month Dividend Program, members receive 4 email notifications over the following 60 days regarding the expiration of the Dividend Program and the options available to them:

1. By activating the **SELL BACK** function, members can request a refund of their invested amount from the company, equal to the original investment. The equivalent value of the invested funds is paid out in **Available USDT**

2. By activating the **SEND TO SHARES B** function, members convert their HTL into **HTL Shares B** with an additional 10% bonus in HTL Shares B. In this case, the member retains the right to receive annual dividends for life.



If 60 days pass and the member has not chosen either of the two options, the system will automatically convert the HTL into **HTL Shares B** with an additional 5% bonus in HTL Shares B, enrolling the member into the permanent dividend program.

DIVIDENDS:

Dividends are calculated annually for the previous year and paid out in the month of May. A minimum of 10% and up to 15% of the value of active real estate assets is allocated to the dividend fund. This amount is then divided by the total number of HTL tokens participating in the Dividend Program (HTL Shares A, Promotional HTL Shares A, and HTL Shares B) to determine the value of one dividend.

HTL Shares A that are still in the **Loyalty Program** (i.e., within active packages and Freedom Programs) are not included in the dividend fund calculation.

Only the HTL tokens that members received during the year for which the dividend is being calculated are eligible for dividends for that specific year. The value of one share is determined based on the exact date it was received. For example, an HTL Share that entered the Dividend Program on **December 31** does not have the same weight as one received on **January 1**.

For every HTL Share value is calculated as the number of active days in the year divided by 365.

•A full share received on January 1 equals 365/365 = 1.

•A share received on **December 31** equals 1/365 ≈ 0.0027.

Therefore, if the dividend value is **1 EUR per HTL Share**, the member would receive:

•1 EUR for a share received on January 1,

•0.0027 EUR for a share received on December 31.

That same HTL Share will earn a **full dividend** in the following year, as it will have been active for all 365 days



The maximum dividend value is capped at **8% of the invested EUR value** at the moment the member received the **HTL Share B**. If the calculated dividend value exceeds this limit, a **coefficient is applied** to cap the member's dividend to a maximum of 8% of the EUR value of the HTL Share B at the time it was created (whether through conversion or as a received bonus).

EXTRAS:

Participation at the VIP Trips, Leadership Training Seminars, Diamond Conferences, or any other incentive events requires from Members the fulfillment of the relevant qualification criteria as well as being in good standing, not in breach of their Member contract with Planet Program, and receipt of the written invitation from Planet Program before the event.

Invitation to the incentive events is at the sole discretion of Planet Program even in case other criteria are met by the Member.

The incentive trips are business events, due to this Members are required to attend all the business sessions, including but not limited to business updates, leadership meetings, product demonstrations, Q&A sessions, and other scheduled business activities.



Failure to attend the scheduled business sessions may be considered as manipulation of the terms of the Program and, thus, the Member may be asked to reimburse Planet Program for some, or all costs associated with Member's participation in this Program, incentive events in particular.
